2018 INTERSESSIONAL MEETING OF THE SUB-COMMITTEE ON ECOSYSTEMS

(Madrid, Spain, 4-8 June, 2018)

#### **Objectives**

#### Pertaining to ecosystems

In conjunction with the proposal to develop an Ecosystem report card for ICCAT, the Sub-committee will review progress on the inter-sessional exercise to assess the status of the 10 ecosystem components that were identified. The indicators described in the assessments are to form the basis for a prototype report card that will be presented to the Commission in 2018. As in 2017, the Sub-committee aims to continue the work required to assess the feasibility of and provide information towards implementing ecosystems based fisheries management (EBFM) in agreement with Resolution 15-11. Furthermore, it will examine the available information on the trophic ecology of pelagic ecosystems that are important and unique for ICCAT species in the Convention area as per Resolution 16-23.

#### Pertaining to by-catch

Recognising that the paucity of seabird by-catch data submitted to the ICCAT Secretariat has prevented an assessment of Rec. 11-09, the Sub-committee noted that there are opportunities to progress this work intersessionally through additional mechanisms. The collaborative work being conducted by relevant CPCs will be presented and the plan will be elaborated to take these collaborations further. There is also a paucity of by-catch data submitted to the ICCAT Secretariat on sea turtles despite repeated requests for this information, the Sub-committee recognizes that a collaborative effort similar to that being proposed for seabirds be initiated. The Sub-committee aims to discuss progress towards scientific collaboration among researchers of ICCAT CPCs to elaborate on the results obtained to date regarding knowledge of the impact of the fisheries on sea turtles.

In 2017 the Sub-committee recognized that several species of teleost fish are also caught as by-catch in ICCAT fisheries. To date these species have generally been neglected as the Sub-committee has focused on non-teleost by-catch. The Sub-committee intends to discuss and bring attention to these species which are often caught in significant quantities.
