Introduction

The 25th Regular Meeting of the Commission was held in Marrakech (Morocco). Over 630 delegates attended the meeting from 44 Contacting Parties, four cooperating non-Contracting Parties, Entities or Fishing Entities and observers from two non-Contracting Parties, six international organisations and 23 NGOs.

During the meeting significant progress was made, including the adoption of nine Recommendations. A number of relevant decisions were made, including:

- ✓ ICCAT elected a new Chairman, Mr. Raul Delgado (Panama), and expressed its profound appreciation for the excellent service of the outgoing Chair, Mr. Martin Tsamenyi (Ghana) over the past two years. The progress made under his leadership was highlighted. Mr. S. Depypere (European Union) was reelected as First Vice-Chair, and Mrs. Zakia Driouich (Morocco) as Second Vice-Chair. Mrs. Lapointe will no longer be available to serve as Chair of STACFAD, and Mr. Hasan Alper Elekon (Turkey) has been appointed as new Chair of STACFAD. Mr. Derek Campbell was re-elected as Chair of COC. Mr. Neil Ansell will serve as Chair of PWG, replacing Mr. Fabrizio Donatella. Regarding the Panels, Côte d'Ivoire, Japan, South Africa and Brazil were also re-elected to chair Panels 1, 2, 3 and 4, respectively. All the officers will serve a two-year term of office.
- ✓ Mr. Camille Jean Pierre Manel (Senegal) has been elected Executive Secretary and will take up his appointment on 1 July 2018. He will replace Mr. Driss Meski (Morocco), who will retire after serving ICCAT as Executive Secretary for 14 years.
- ✓ During the Commission meeting, the confirmation of adherence to the Convention by Grenada was received. Grenada was welcomed as the 52nd ICCAT Contracting Party.
- ✓ The new approved TAC for eastern Atlantic and Mediterranean bluefin tuna for 2018 is 28,200 t, and is set at 32,240 t and 36,000 t for 2019 and 2020, respectively.
- ✓ A new four year management plan up to 2021 was approved for Atlantic swordfish.
- ✓ Supplementary measures (ban on wasteful discards from the purse seine fishery) were adopted for tropical tunas, in an attempt to ensure food security for the coastal States affected by these fisheries.
- ✓ Additionally, an agreement was reached on measures for the northern stock of shortfin make shark; Harvest Control Rules for northern Atlantic albacore were agreed; and, technical details of the electronic bluefin catch document scheme (eBCD) were tweaked.

External meetings

Between September and December 2017 members of the Secretariat staff have participated actively in five meetings and activities related to ICCAT providing both written and/or oral contributions.

The Tuna Compliance Network held its 2nd meeting in Honiara, Solomon Islands, 15-18 February 2018. This meeting brought together officers responsible for compliance and officers responsible for data management from the five tuna RFMOs to share ideas on ways of improving data flows and information sharing in order to positively impact their compliance process.

OTHER ACTIVITIES

The ICCAT/Japan Capacity-Building Assistance Project (JCAP) held a capacity building course in São Tomé e Príncipe (15-19 January) to improve data collection onboard tuna fishing vessel.

ONGOING RESEARCH AND DATA COLLECTION PROGRAMMES

Phase 7 of the *Atlantic-Wide Research Programme for Bluefin Tuna (ICCAT GBYP)* continued activities including data recovery, aerial surveys, biological studies, tagging trials and modelling approaches (additional information). In January 2018 a new Coordinator (Dr Francisco Alemany) was appointed to replace Dr Antonio Di Natale who has retired after serving ICCAT for seven years. The Phase 8 proposal has been prepared aiming at the continuation of the programme, with an overall budget of €1,750,000.

Since last September the *Atlantic Ocean Tropical tuna Tagging Programme (AOTTP)* has continued to tag tuna, most recently off South America (Brazil and Uruguay), the US Atlantic coast, and the Madeira archipelago. To date more than 64,500 tropical tunas have been tagged and more than 11,500 recovered with their valuable associated metadata. Otolith reading and general tag data analytical workshops were held.

Small Tunas Year Programme (SMTYP) continued developing biological studies on key population parameters for selected small tuna species off the northeastern coast of Africa and southwestern Europe. A new cooperative and coordinated approach was recently approved as such activities are essential to conduct small tuna assessments in the near future.

Enhanced Programme for Billfish Research (EPBR) continued its activities, namely in terms of the collection of billfish fisheries statistics off the western coast of Africa. The objectives of EPBR have recently been expanded to evaluate habitat use, study spawning patterns and population genetics, as these are essential to improve billfish stock assessments.

Shark Research and Data Collection Programme (SRDCP) focused efforts on four major activities that were considered essential for shortfin make shark assessment, including: age and growth study; population genetics; stock boundaries, migrations and habitat use; and, post-release mortality on pelagic longline fisheries.

ASSISTANCE FUNDS FOR DEVELOPING STATES

In 2017 the Meeting Participation Fund for Developing ICCAT Contracting Parties (Rec. 14-14), funded the attendance of 90 delegates from 26 CPCs to ICCAT scientific and non-scientific meetings.

PUBLICATIONS

Volume 74 of the *Collective Volume of Scientific Papers* (Vol. 74), including 176 scientific documents and reports presented to the SCRS during 2017, was published.

ICCAT is chairing the joint tuna-RFMO MSE Working Group. The 2nd meeting of this group will take place from 13-15 June, Seattle (USA).
