

HISTORY OF ACTIONS TAKEN BY THE COMMISSION FOLLOWING REVIEW BY THE COMPLIANCE COMMITTEE SINCE 2009

In 2009, the Compliance Committee began a review by individual CPCs, rather than by theme as previously. COC_308/16 is an Excel file. The columns for previous years are hidden in order to allow the last two years to be printed. However, it was previously agreed by the Compliance Committee that compliance history should be taken into account when considering actions to be taken regarding CPCs.
