Subject: Letter of Concern regarding compliance issues in 2015

Dear Mr. Campbell,

Thank you for your letter dated February 12th 2016 in regards to the subject matter. In response thereto, please note the following:

a. The reporting summary of the Annual Report Part II was received late

Based on our records, our Annual Reports part I and II and annexes were submitted on 7th August and 27th July 2015 respectively, well in advance of the required deadline. The late submission of the Part II Summary Table was an administrative oversight on our part and once notified of its non-submission we immediately submitted the report on 27th October. We appreciate the importance of submitting reports on time so that they can be consolidated and assessed by the Secretariat. Belize have always submitted these reports in a timely manner and will ensure that all future reports are submitted on or before their deadline dates.

b. The Task II data were submitted in an incorrect format

Similar to the above this was an administrative error on our part. With the changes to the ICCAT reporting forms, we had neglected to update these forms in our system. We have ensured that the correct forms have been utilized in our subsequent submissions.

c. The North Swordfish management plan was not submitted in accordance with par.3 of Rec. 13-02

As there were no changes to our management plan since its previous submission, we did not deem it obligatory to re-submit the same document. As a result of the identification of non-compliance regarding this matter we acknowledge that regardless of changes made to the document or any document thereto, same should still be submitted. As such we have since submitted this document and will ensure its future annual submission.

d. Information on several vessels was submitted to the Secretariat for inclusion in the JC CAT regard of vessels with an authorization period that included dates mort ha 45 days prior to the date of submission.

As a result of the changes to the vessel reporting requirements and how vessels are included on the ICCAT website, there were some misunderstanding on our part which resulted in this non-compliance. However, with guidance from the Secretariat we were able to sort out this matter and have since made all our vessel submissions in accordance with Rec 13-13 and Rec 14-10.

We hope that the above address all the Committee's concerns. If any further clarification is required please do-not hesitate to contact the undersigned. This Administration avails itself of the opportunity to renew the assurances of its highest consideration.

Subject: Response from Côte d'Ivoire to the ICCAT Letter of Concern

Dear Compliance Committee Chair,

<u>In the name of the Delegation of Côte d'Ivoire, I am writing this letter in response to your Letter of Concern transmitted to Côte d'Ivoire on 12 February 2016.</u>

In the name of the Government of Côte d'Ivoire, I note the data reporting deficiencies reported in 2014.

The internal measures implemented by my country to remedy these deficiencies are as follows:

- The team who processes ICCAT files has been strengthened with a statistician and more implication on behalf of two scientists for a better follow-up. This provision will allow to transmit a full report.
- As regards the Letter of prohibition due to the non-reporting of data for Task I in 2013, this issue was resolved at the 24th Regular meeting of the Commission, which was held in St. Julians (Malta) in 2015.
- Recommendation 13-02 applies to CPCs whose vessels actively fish for swordfish in the North Atlantic, and given that Côte d'Ivoire does not have vessels that target this species since 2010, and that this was clearly stated at the Commission meeting in Istanbul in 2011, we considered that it was not useful to draft a development plan which applied to this species.

Trusting that the Compliance Committee recognises the progress carried out by my country, I would like to guarantee that Côte d'Ivoire will continue to deploy every necessary effort to comply with its obligations with respect of ICCAT.

I express greetings and write in response to the Letter of Concern regarding reporting deficiencies of Liberia at the 2015 24th Regular Meeting of the Commission of ICCAT (10-17 November 2015, St. Julian's Malta). Whilst we recognize the fact that Liberia's 2015 annual report was submitted late, all efforts are being made to ensure that the 2016 annual report (Parts I and II) are submitted at least on or before the established deadline.

Meanwhile, in an attempt to ratify the reporting inadequacies, Liberia has taken the necessary steps by assigning staff who will be solely dedicated to specific tasks related to ICCAT aimed at fulfilling our responsibilities to the Commission, though Liberia as a new developing CPC is somewhat new to the processes and procedures of ICCAT coupled with the reform currently going on in the fisheries sector.

We are confident that the deficiencies noted in Liberia's 2015 annual report as indicted in your communication will be addressed to the best of our ability. At this stage, recommendation by ICCAT on compliance with existing measure on shark conservation and management [Rec. 12-05] has not been implemented by Liberia. Liberia will try to initiate the necessary actions to commence the implementation on shark conservation and management measure.

One has to bear in mind that unfortunately Libya is passing through an uncomfortable period in its evolution, and gathering of statistics and data from the various fishing localities can be at times difficult.

However we shall make our best endeavors to rectify the situation."

SUBJECT: LETTER OF IDENTIFICATION

The Delegation of Trinidad and Tobago conveys its compliments to the Commission and its Secretariat and reaffirms its commitment to management of the Atlantic tuna and tuna-like fisheries for the benefit of existing and future generations.

Reference is made to your Letter of Identification dated 12 February, 2016 which in the main seeks responses relating to the following deficiencies identified with regard to Trinidad and Tobago's compliance with ICCAT conservation and management measures:

- Task II catch and effort or size data were not submitted,
- Continued significant overharvest of blue marlin and white marlin and lack of domestic management measures in place for these fisheries, including logbook requirements and trade monitoring.

Task II data catch and effort and size submission

Please be assured that Trinidad and Tobago is fully cognisant of the importance of data and reporting deadlines in the context of the work of the Commission, including its Panels and Committees and the Secretariat. While the limitations and constraints expressed in previous responses to the Committee continue to be evident, data collection and reporting to the extent possible continue to be highly prioritised. In this regard, we wish to register the following significant improvements in our reporting for 2016:

- 1. Task II size data were submitted for the first time this year, albeit preliminary and past the deadline;
- 2. Trade measures import and landing data were submitted for the first time this year and on time.

Trinidad and Tobago faces considerable challenge in implementation of its data collection programme to provide length-based Task II size data, due mainly to lack of staffing. In this regard, the Fisheries Division continues to bring before the administration the necessity for expansion of its human resource capacity. However, we shall continue to prioritise the collection and submission of weight-based Task II size data and shall seek to improve on its reporting in 2017 and beyond.

Overharvest of blue marlin and white marlin

With respect to the control of marlin catches, we reported to the Compliance Committee in 2015 that various actions were being taken including the use of alternative bait and the close monitoring of landings. It is noteworthy that in 2015 there was a 27% decrease in landings of blue marlin and a 17% decrease in landings of white marlin in comparison to 2014 landings although it has not been determined whether this decrease was the direct result of the use of alternative bait.

Over the past year, cognisant of the level of overharvest and with focus on conservation of the resources, additional measures have been implemented as follows:

 Prohibition of export of blue marlin and white marlin with effect from April 2016 until further notice;

- Prohibition in the landing of all marlin, whether live or dead when caught, with effect from August 2016 until further notice; and
- Vessel captains are required to record marlin catch at sea, another step towards full implementation of logbooks.

In all instances the penalty for non-compliance will be revocation of the fishing licence.

Trinidad and Tobago wishes to reassure the Compliance Committee of its dedication to improving its management regime for Atlantic tuna and tuna-like species. We again hope for the understanding and support of the Committee on these matters and wish the Committee success in its 2016 deliberations.

Honourable Doctor, allow me to take this opportunity to greet you. The purpose of this letter is in response to your correspondence S16-00925, dated 12 February 2016, whereby the Compliance Committee requests information regarding the information deficiencies identified following your revisions.

In this regard, I would like to clarify the following issues in your letter:

- Part II of the Annual Report and the reporting summary of Part II were not submitted: Part Part II was sent on 15 October 2015 to the following address: paul.debruyn@iccat.int and stats_info@iccat.int, which also includes the reporting summary of Part II.
- No Task I fleet characteristics were submitted: Task I ST01-T1FC FORMAT, Fleet Characteristics, was sent on 31 July 2015 to stats_info@iccat.int, in a file under the name VENSTAT 2015, together with the other formats corresponding to the tasks.
- North swordfish management plan was not submitted, in accordance with par. 3 of Rec. 13-02: The swordfish management plan was sent in CP-41 NSWO Plan format, to the same address, stats_info@iccat.int, dated 14 September 2015.
- Continued overharvest of north albacore catches [Rec. 13-05]: As regards albacore catches, since 2014 and as part of the Action plan, Venezuela implemented the discards of this species aimed at reducing overharvest. Currently, a domestic Resolution is being developed to support it and will enter into force from 2017.
- Blue marlin overharvest since 2014 [Rec. 12-04]: The Secretariat should revise the data sent on blue marlin for 2014 as Venezuela has not reported overharvest in catch levels for this species.

Taking into account the above mentioned information, we kindly request that the Committee carries out a new revision upon which these information deficiencies were detected in order to determine Venezuela's compliance regarding the information requirements stated.

With the aim of complying with the Committee's requirements, please accept the assurances of my highest consideration.
