As LFRPDA conducted a national training programme for local fisheries observers of Egypt on ICCAT data collection and reporting, in collaboration with the NIOF in the 2025 fishing season funded by ICCAT/Japan Capacity-building Assistance Project (Phase 3). The programme focused on improving the capacity of local observers in Egypt to raise their efficiency in identifying ICCAT species, collecting standardized data, meeting the requirements for preparing comprehensive reports, improving data quality, and developing a replicable training program for observers that can be used in future capacity building efforts. Also the Arab Academy for Science, Technology & Maritime Transport (AASTMT), as safety at sea and survival training require specific skills and knowledge best provided by professionals with direct experience in maritime safety and rescue operations. AASTMT personnel are ideally suited to deliver the "Safety at Sea, Use of Survival Equipment" in collaboration with LFRPDA.

However, we only authorize for ALB-MD for some of vessels and issue a national decree to prohibit fishing of this species. That decree states that “only the registered ALB-vessels in ICCAT were authorized to catch for ALB-MD” for which our national inspectors do their best to control the vessels not to exceed the allocated quota knowing that we tried to control the catch by decreasing number of authorized vessels but the catch per unit effort was high and the authorized vessels catches were more than their allocated quota.</p> <p>Moreover, at the 23rd Special Meeting of ICCAT, Egypt ALB-MED quota was (177.27 ton) but we were asked to sacrifice by decreasing our quota to (150.27 ton) although we have abundance of ALB-Med in our territorial water . That decrease caused an evolution among our fishermen as we sacrificed with their rights although we have a historical catch of this species exceeds our allocated quota. There is no doubt that our fishermen request their rights and we do our best to manage this issue which is related strongly with their livelihood</p> <p>Regarding the SWO-MD; all over the past years we requested many times to have an allocated quota for Egypt, where in 2022, the commission asked us to submit a fishing plan and a list of authorized vessels in addition to a management plan for this species. Egypt comply with all requirements and submitted all requested documents for the fishing seasons 2023 &amp; 2024 for which we have no comments from any CPCs during the last years as it's our right to have a quota as one of panel 4 member. Also it was so hard to control the fishermen not to fish for this species as it has abundance in our territorial water. In addition that CPCs having allocated quota of SWO hadn't catch all amounts specified for them so that Egypt hadn't any negative impact on the stock.</p> |  |

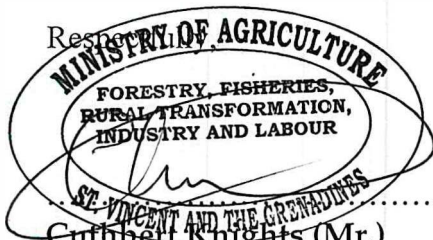
Dear Mr. Derek Campbell,
