Re: Barbados' Responses to Compliance Issues

Greetings from the Fisheries Division. I hope this communication finds you well and in good health.

We are writing to formally respond to the three compliance issues included in the attached table created with the template supplied. However, through this letter we would like to more fully respond specifically to the request for additional information on actions being implemented and submission of an action plan for the payback of the reported overharvesting of Blue and White marlins.

As you will recall in our response dated 9 October 2024, we reported that on 1st July 2024, the powerful storm surge generated by the passage of category 4 Hurricane Beryl to the South of Barbados severely damaged the breakwater at the Bridgetown Fishing Harbour, where the majority of the island's pelagic fishing vessels including the entire longline fleet were berthed. More than 200 fishing vessels of various kinds suffered major damage as a result of this one incident, with more than 70 being completely destroyed. Of that number, one longliner was lost entirely and 38 were damaged. Even though some of vessels were repaired and put back into service before the end of the year, this incident led to an overall significant decline in fishing activity for the rest of the year, including that of the longliner fleet. Recovery efforts are ongoing, and a vessel replacement project will be launched in the coming weeks.

This in turn resulted in a substantial reduction in the catches of all fish species including marlins. As such the landings of white and blue marlins for 2024 was much lower for any previous year and below the respective 10 t quota/limit set for these species.

It must be noted that even though Barbados catches of blue and white marlin have been kept below the respective allocated 10t catch limit/quotas, in 2022 through 2024, the 25% penalty, triggered by the catch overages up to 2021, has left the island burdened with a significant accrued catch overage, which represents biomass that were never actually taken from the stock in the first place and thus in no way contributed to the status of the stock. In this context, even despite remaining below the annual quotas over the last three years, Barbados still remains mired in significant catch overages for the marlin species, for which there is no apparent workable means of "payback" within a reasonable timeframe.

In this regard it must be reiterated that most marlin catches are taken incidentally by the local longline fleet, which primarily targets yellowfin and bigeye tunas in fishing areas also abundantly inhabited by marlins. For this reason, the likelihood of incidentally catching marlins is high and it is only an overall reduction in fishing effort that could perceivably significantly reduce marlin catches. This is obviously untenable as it would result in making the fishery economically unviable, further resulting in significant losses in employment and the island's food supply. Furthermore, it should be emphasized that marlins are only sold and consumed locally and as such these species intrinsically contribute to the island's food security and the livelihoods of fisherfolk, especially now so against the backdrop of the significant diminution in catches of Barbados' keystone flyingfish and dolphinfish fisheries as a result of the annual incidences of sargassum inundations of the island's fishing areas and the continued post-Beryl reduction in size of the fishing fleet.

Given the above, Barbados is in no position at the moment to present a cogent short-term payback plan for the existing overages of marlin catches. Further in this context noting the inherent uncertainties in the degree and rate of recovery of its fishing fleet and the overarching food security imperatives.

Nevertheless, it should be noted that Barbados and other Caribbean small island developing states will be tabling a Recommendation in Panel 4 at this year's meeting seeking rationalization and relief of the treatment of marlin overages. However, ICCAT is urged to note the commitment by Barbados to continuing efforts to reduce marlin catches to the extent reasonably possible inter alia through legislation. In this context I am happy to report that the Sustainable Fisheries Management and Development Act, 2025 and the sister Sustainable Fisheries Management and Development (Seafood Markets and Business) Act, 2025 came into force on May 12th, 2025. Along with subsidiary regulations, this body of legislation will effectuate comprehensive regulation of the harvest and post-harvest sectors. The subsidiary Sustainable Fisheries Management and Development Regulations to the Sustainable Fisheries Management and Development Act, 2025 are currently undergoing the final processes for commencement.

In the context of catch reduction of marlins, the regulations mandate (a) that longlines are not to be deployed, set or used with specialized fishing tackle; specific bait; or fishing technology, to target billfish (b) that only circle hooks of a size greater than 16/0, and not offset; or 18/0, with an offset no greater than 10 degrees are to be used on longlines (c) that any billfish incidentally taken on longlines that are alive at haulback are to promptly released in a manner that maximizes their survival accordance or if already dead, a percentage of the fish as specified by the Chief Fisheries Officer may be retained and disposed of in accordance with such conditions as she specifies.

In this context it should be noted that circle hooks are already being used by some longliners and that an experimental fishing exercise started in October 2025 to test the relative efficacy of these hooks in reducing unwanted bycatch. Another study testing the impact of water depth on catch composition will follow to advise on the possible introduction of legislation to regulate fishing depth ranges to reduce incidental by-catch catch rates of a number of species including marlins.

We hope that the narrative above sufficiently conveys our concerns and commitment to promoting sustainable fisheries for all Barbadians.

While these methods are aimed at curbing catches of billfish including marlins in an effort to comply with the current set quotas, the Commission is reminded that billfish are eaten in Barbados and contribute to the island's food security in addition to being an important component of the catches of the island's longline fleet and thus the economic viability of that fishery and the livelihoods of fisherfolk. It should also be noted that longliners are targeting yellowfin and bigeye tunas in fishing areas abundantly inhabited by marlins. For this reason, marlins are caught incidentally but are consumed and contribute to food security. It should also be noted that the fishing fleet is still recovering from the passage of hurricane Beryl which damaged 160 vessels and completely destroyed over 70 vessels after further assessment was carried out. Of this number 38 longliners were damaged and 1 completely lost. The fishing activity of the longliner fleet has not yet fully recovered from this impact which has led to a concomitant reduction in fish catches inclusive of marlins.

Protection of endangered species states that: “(1) No person shall hunt, capture, possess, trade in, intentionally kill, injure or harass any endangered species. (2) A person shall report to the Chief Fisheries Officer any accidental catches of species prohibited under subsection (1). (3) Any endangered aquatic species caught, either intentionally or unintentionally shall be released immediately and returned to the water from which it was taken with the least possible injury. (4) The Chief Fisheries Officer shall maintain lists of endangered species and threatened species.” Expanded operational details pertaining to this clause are articulated in the subsidiary Sustainable Fisheries Management Regulations which duly lists sea turtles as endangered species and mandates that “No person shall fish for; take; endanger, harass, harm or kill; land; possess without the written permission of the Chief Fisheries Officer; sell or expose for sale; or purchase, any species of fish considered endangered any species of fish considered endangered listed in Part II of the Second Schedule”. Additionally, the regulations mandate that in relation to listed endangered species (such as turtles “The master of a commercial or sport fishing vessel shall promptly release fish, to which this paragraph applies, incidentally caught or entangled in fishing gear and still alive at haul-back in (a) a manner that causes the least harm to the fish and maximizes the possibility of survival; and (b) in accordance with such instructions as the Minister, on the advice of the Chief Fisheries Officer ”. Furthermore, the regulations stipulate that “the master of a commercial or sport fishing vessel shall ensure that the equipment required for the purpose of release of fish of a size and design approved by the Minister and as the Minister, on the advice of the Chief Fisheries Officer, may specify by notice; such equipment must be kept on board the vessel for the duration of every	

	Rec. 22-01: Periodical reports received late.	fishing trip, be maintained in good working order and the master and the crew are trained in the safe and effective use of the equipment.” In the case of turtles, the instructions referred to above in the context of both the size and type of equipment and best practices to be used to release turtles will be articulated in Fisheries Notices subsidiary to this regulation and will be advised by the “FAO Guidelines to reduce sea turtle mortality in fishing operations (2009)” in the context of longline gear and for resuscitation of sea turtles on board as detailed in appendix 2 of ICCAT Rec. 22-12. In relation to reporting obligations re incidental fishing encounters with turtles, the regulations also mandated that “A person shall report to the Chief Fisheries Officer any accidental catches of prohibited species” (including turtles) and to this end “The master of a commercial or sport fishing vessel shall maintain records of all fishing activities for every fishing trip” and this includes “the incidental catch, injury or killing of fish of any species listed....[this includes turtles]...” for which fishing is prohibited” In compliance with Rec. 22-12 Para 1 (a) the SFMDA regulations also mandate that for horizontal longlines, “Only circle hooks of a size greater than (a) (b) 16/0, and not off set; or 18/0, with an off set no greater than 10 degrees.” may be used. Barbados apologizes for the delay in submissions and is trying to remedy the situation through the onboarding of an additional Fisheries Biologist and Data Analyst to support the necessary collation and analysis of landings statistics to facilitate timely submissions of reports. This will be further facilitated through the introduction of a bespoke Fisheries Information Platform with Intergen Technology which includes a robust database, Application Programming Interfaces (APIs) for integration, and a user-friendly dashboard that will collectively allow for immediate collation, summarisation and reporting of directly inputted fisheries related data from various sources including from digitised fish landings data collected from conventional market records as well as fish catches, fishing trip details, and economic information collected by data collectors through and directly digitized through the KoboToolbox. Platform, vessel tracking information collected from the Vessel Monitoring systems (VMS) currently installed on nearly all

		longliners, noting that under the SFMDA(2025) all fishing vessels will by law have to carry remote tracking devices, detailed information on on-board fishing activities including AI monitoring of the catches allowing for species identification and estimation of catch weights etc. with Electronic Monitoring Systems (EMS) being installed initially on longliners, as well as catches landed at key market sites using Smart Scales that will inter alia identify species, conduct digital biological sampling, determine catch location, calculate fishing effort, analyse landings and begin the traceability certification process.	
<i>MCS General</i>	Rec. 16-14: Implementation of scientific observer programme unclear. Observer coverage <5%.	An observer program has not been implemented in Barbados yet. However, PART X of the SFMDA (2025) is devoted with the requirements for the Chief Fisheries Officer to establish an observer program and includes the duties of an observer and responsibilities of the owner of the vessel or facility in which a fisheries observer is placed. The SFMDA regulations adds more details for the observer programs including that; the master of both a commercial or sport fishing vessel shall fully participate in any observer program authorised by the Chief Fisheries Officer including accommodating and this includes the installation of any on board electronic surveillance equipment deemed necessary to allow the unimpeded observation of all on board fishing and related activities. In this context, under the Strategies, technologies, and social solutions to manage bycatch in tropical Large Marine Ecosystem Fisheries (REBYC-III CLME+) project, Electronic Monitoring Systems (EMS) from the company Shellcatch have been implemented on the longliner fleet. Mr. Derek Campbell,

1. Brazil acknowledges the receipt of your letter on compliance issues addressed, dated September 11th, 2025. We are grateful for your attention to these concerns and for the opportunity to provide the necessary clarifications. Accordingly, we present below some clarifications on the issues raised for the Compliance Committee's consideration.
2. Under the ICCAT conservation and management program for tropical tunas adopted by the Commission (Rec 21-01; Rec 22-01; Rec 23-01), Brazil recognizes the recurrent overharvest of bigeye tuna (BET) in 2023. This led the country to submit - and had approved at the last Commission meeting - a new payback plan (Rec. 24-03). Under this recommendation, Brazil committed to repaying, over a four-year period (2025-2028), the remaining overharvest of 1,232 t from 2022 and 922.03 t from 2023. of 922.03 t from 2023.
3. Following consecutive years of BET overharvest, Brazil has made significant efforts to address these issues by improving the regulatory framework and encouraging stakeholders to take practical actions to enhance compliance. In September 2023, Brazil forbidden the BET landings for its hand-line fisheries and on December 15 all the fisheries interacting with BET were closed, reopening them on January 1, 2024.
4. The result of the closure of fishing in 2023 was that schools of BET that had been monitored for years by the Brazilian fleet were lost, leading to a reduction in catches of the species in 2024 compared to previous years. For 2024, the Brazilian tuna and tuna-like fisheries did not record any BET overharvest.
5. Brazil continued to strengthen its systems to monitor and control tuna and tuna-like fishing by ordinances, as the Interministerial Rule MPA/MMA N2 10, 26 of March of 202 which established the catch limit of tropical tunas and the Interministerial Rule MPA/MMA NQ 12, 02 of August of 202 that established a catch limit controlling system for BET for 2024.
6. This strengthening is also related to monitor port landings for tuna fisheries at end of the 2023. On January 1, 2024, Brazil implemented the national long-term research and data collection program (PMPA - Tuna and tuna-like fish monitoring program in Brazil), which will surveil onboard observers and port monitoring all tuna and tuna-like fishing fleets across the country's coastline. This program, registered under number has a total budget of 2 million euros over its four-year duration.

7. However, since 2024 was the first year of implementation of this rebuilding program, it was not yet possible to achieve the observer coverage defined in Recommendation 16-14. Therefore, the available ST09 data was insufficient for submission. Brazil acknowledges this shortcoming and reaffirms its commitment to reaching the required observer coverage as soon as possible, through the consolidation of the PMPA.
8. Regarding the no information on implementation of sea turtles measures as defined on the Brazil has established since 2017 by the Interministerial Rule N2 74, 1st November 2017 which establishes the mandatory use of circle hooks by all longline fishing vessels. This measure defines as mandatory use of some equipment and mitigation measures to reduce bycatch mortality, this includes billfish and turtles. Examples of equipment include: I - hook unhookers; II - line cutter; III - hook cutter, as well as protocols for its use.
9. In addition, Brazil would like to highlight that it currently establishing and formalizing internal deadlines for data delivery, consolidation, and reporting to prevent delays in future submissions.
10. Finally, Brazil continues to strengthen transparency of information. As a monitoring and control measure, Brazil has made publicly available a dashboard showing the catch limits for species in 2024 ([Access the dashboard here](#)). In 2025, this initiative was continued and expanded to also include the Blue Shark ([Access the dashboards here](#) - BSH and

In response, Canada has been diligently working to address this issue and has held regular consultations with observer service providers, fleet representatives, scientists, and enforcement officials to reinforce the critical and mandatory nature of observer coverage within the longline fleet. These meetings have also served to identify actionable support, whether through improved data sharing, logistical coordination, or departmental assistance that could help Observer companies optimize coverage levels despite reduced staffing. Restoring observer capacity and meeting ICCAT commitments remains a priority for Canada, with sustained collaboration and targeted support central to Canada's recovery efforts.

On behalf of the General Directorate for Fisheries and Aquaculture (DIGEPESCA) of Honduras, we extend our warmest greetings and best wishes for success in your work. We appreciate the communication received on 11 September 2025 (Ref. S25-08884), indicating deficiencies related to Honduras' compliance with its ICCAT commitments. In response to this, and as requested, I am pleased to forward our country's official response.

Section 1: Deficiencies identified

1. Rec. 18-07 – Confirmation of zero catch:

We acknowledge that the confirmation was submitted late due to internal data consolidation processes. Honduras has established an updated administrative procedure that ensures the timely submission of this information within the established deadlines.

In compliance with the Commission's request, Honduras has developed a National Action Plan, attached to this letter, which describes in detail:

- Commitment to strengthen cooperation with the ICCAT Secretariat in the areas of training and technical assistance.

Honduras reiterates its firm commitment to complying with ICCAT Recommendations and Resolutions, as well as to strengthening transparency in data reporting and the implementation of conservation and management measures.

We also express our willingness to work closely with the Secretariat and with CPCs that can provide technical assistance and capacity-building programmes, in particular for the improvement of data collection systems and bycatch monitoring.

		The Agreement also establishes that the specimens of shark indicated therein, as well as other non-target species subject to the special protection regime that are caught, must be released in the best conditions of survival, thereby strengthening the conservation measures and fishery sustainability. The provisions are mandatory for concession and fishing permit holders, as well as for fishing captains or skippers, driver or operations, fishers and crew of these vessels and any other individuals that carry out tuna fishing activities in the federal waters of the United Mexican States of the Gulf of Mexico, Caribbean Sea and the Convention area of the International Commission for the Conservation of Atlantic Tunas (ICCAT). Similarly, it is provided that persons who do not comply with these provisions will be subject to the sanctions established in the General Law on Sustainable Fisheries and Aquaculture and related applicable legal provisions. With these actions, Mexico reiterates its commitment to strict compliance with the international obligations on conservation and responsible management of highly migratory species, and continues to strengthen the national mechanisms to ensure traceability, legal origin and sustainability of the fisheries under its jurisdiction. SUBJECT: RESPONSE TO IDENTIFICATION UNDER ICCAT'S TRADE MEASURES RECOMMENDATION

Dear Executive Secretary,

Namibia acknowledges the recent identification by ICCAT concerning the overharvest of Blue Marlin (*Makaira nigricans*) and appreciates the opportunity to provide a formal response outlining the measures taken to address this matter and enhance our compliance with ICCAT conservation objectives.

1. Acknowledgment of Overharvest

Namibia regrets acknowledging the continued overharvest of Blue Marlin in previous years and takes this matter seriously. One of the biggest challenges we face is the accurate identification of Blue Marlin. We are of the opinion, having engaged fisherman from different vessels that are recording Blue Marlin catches that fisherman including skippers and Observers do not agree on the accurate identification of Blue Marlin. We are committed to ensuring sustainable fisheries management and aligning our national measures with ICCAT's conservation and management requirements.

2. Measures Implemented to Address Non-Compliance

To address the issue of Blue Marlin overharvest, Namibia has implemented a number of control and compliance measures, including:

- **Enhanced Industry Engagement:** Regular consultations have been conducted with right holders and the fishing industry to raise awareness about Blue Marlin catch limits and the importance of adherence to ICCAT conservation measures.
- **Improved Reporting Systems:** A structured reporting mechanism requiring weekly, monthly, and quarterly submissions from fishing operators has been implemented to closely monitor Blue Marlin catches.

- **Observer and Inspector Monitoring:** Fisheries observers have been instructed to specifically monitor Blue Marlin catch rates at sea, while fisheries inspectors carry out landing inspections at ports to verify compliance.
- **Impact of Measures:** As a result of these interventions, Namibia has recorded a **significant reduction in Blue Marlin catches during the last fishing year**, demonstrating positive progress towards compliance.

3. Additional Measures for Species Conservation

Namibia has also taken steps to mitigate the impact on other ICCAT species, particularly the Shortfin Mako shark (*Isurus oxyrinchus*), through the following actions:

- **Live Release Policy:** All live Shortfin Mako sharks brought onboard are released back into the ocean, while only dead individuals are retained and landed in accordance with Namibia's anti-discard legislation.
- **Avoidance Measures:** Fishing vessels have been instructed to avoid areas with high Shortfin Mako bycatch.

Please note that these measures were implemented in June –July 2023, and therefore, only partial results are currently visible. However, initial trends indicate a **notable decline in Shortfin Mako catch rates**.

4. Data Reconciliation and Task 1/2 Reporting Improvements

Namibia recognizes discrepancies between Task 1 and Compliance Tables and has adopted corrective measures, including:

- Training of data-capturing staff;
- Cross-verification and reconciliation of data between fishing vessels and the Ministry before submission to ICCAT;
- Reduction in the number of vessels operating under Namibian quotas;
- Suspension of all foreign-flagged fishing operations within Namibia's EEZ;
- The catch data are monitored frequently; measures are in place to limit the overharvest of national ICCAT quotas.

5. Observer Coverage

Despite the provision in Namibian Law for all Namibian Licensed Fishing Vessels to have an Observer onboard, our observer coverage regrettably remains under 50%. Efforts are ongoing to improve Observer coverage and data collection.

Conclusion

Namibia remains fully committed to the sustainable use of marine resources and the objectives of ICCAT. We respectfully request that our recent efforts and demonstrated improvements be duly taken into consideration. Namibia will continue to work closely with the Commission to ensure ongoing compliance and effective fisheries management.

Should further clarification or documentation be required, we stand ready to provide it.

The bigeye tuna overharvest for 2020 was resolved with the *Recommendation by ICCAT on Senegal's bigeye tuna payback plan* (Rec. 23-03) was adopted by the Commission in November 2023. The ST09 for 2024 was submitted to the Secretariat within the deadline. For 2023, there was no overharvest.
3. Rec. 18-06: Shark (SHK) check sheet received late. Neither ST03 (catch and effort) nor the ST09 (observer data) was received.
The 2024 shark check sheet was submitted one day late (16/09/2025), ST03 and ST09 were submitted by the deadlines for 2024 and 2025.
4. Rec. 22-01: Task 1 relating to tropical tuna species was submitted in 2023, but no corresponding periodic report was submitted.
Task 1 was submitted by the deadline for 2024. The periodic reports on tropical tunas species data were not submitted. This situation was remedied through the introduction of electronic logbooks on board tuna vessels within the context of implementation of the 2024-2025 action plan, submitted by Senegal to COC in April 2024. In 2025, tropical tuna data (quarterly, monthly) for the first two quarters have already been submitted to the ICCAT Secretariat by the deadlines.

With the objective of improving compliance, an action plan, clearly describing the measures that will be taken to resolve the matters referred to above, was submitted. The progress on its implementation is presented in the table in the Annex.

As regards the issues raised by the European Union within the context of the process contained in Rec. 08-09 and the subject of ICCAT Circular S25-0792 of 18 July 2025, Senegal intends to provide a response, by 16 October 2025, as indicated in that circular.

Senegal reiterates its commitment to improve its compliance with Recommendations and ICCAT reporting requirements.

It also identifies those areas where Trinidad and Tobago intends to seek technical and capacity-building assistance from the ICCAT.

Dear Mr. Derek Campbell;

With reference to your letter dated 11 September 2025, on behalf of the Republic of Türkiye, firstly I would like to thank the Commission for its observations conveyed in the letter regarding the implementation deficiency noted during the 24th Special Meeting of ICCAT.

In response to the deficiency identified under Recommendations 18-07 and 22-08 concerning an overharvest of bluefin tuna in 2023 (-35.131 t), Türkiye wishes to provide the following explanation:

Carryover of underharvest from 2022 was inadvertently reported as higher in Türkiye's bluefin tuna fishing, inspection, and capacity plan adopted by Panel 2 in 2023. As the miscalculation made in 2023's adjusted quota could only be noticed at the end of the fishing season, a remedial action was taken in the following season by deduction of the corresponding amount of overharvest from Türkiye's 2024 national quota.

Accordingly, the amount exceeded has been fully compensated (100%) in 2024, and the necessary administrative measures have been implemented to avoid any recurrence of such an issue in the future.

I also would like to reiterate that Türkiye has provided explanations on its quota adjustments for 2023 and 2024 as footnotes in documents COC-304_Rev.2 to be discussed during 24th Special Meeting of ICCAT.

Türkiye always attaches great importance to the compliance issues and remains fully committed to the effective implementation of ICCAT conservation and management measures and to maintaining close cooperation with the Secretariat and the Compliance Committee in this regard.

The United States acknowledges your letter S25-08836 received on September 11, 2025 in relation to a 2024 compliance concern and would like to take the opportunity to respond.

Due to the dynamic process of U.S. vessel permitting, the United States submits monthly updates of its authorized vessels to the ICCAT Secretariat to comply with Recommendation 21-14 and Recommendation 22-01. On July 18, 2024, the United States submitted a supplemental list of 12 authorized U.S. vessels to the ICCAT Secretariat. These 12 vessels were not submitted as a part of the prior month's update due to a technical error in our domestic permit database. This resulted in these U.S. SWO-N, ALB-N, and TRO vessels having periods of authorization that included dates more than 45 days prior to the date of submission to the ICCAT Secretariat. However, these vessels were appropriately permitted and authorized domestically in line with the dates and information in the CP01 form submitted in July 2024. The technical error in the permit database was resolved in that same month. We have addressed the issue and do not expect this mistake to be repeated in the future.

I would like to thank you and the Secretariat staff for your continued hard work and effort to carry out and continuously improve the ICCAT Compliance process, which is foundational to our work as a Commission. The United States remains committed to a robust and consistent compliance process, and we are available to answer any further questions you may have.

It is my honour to address you and extend my warm regards to you. I would like to respond to the concerns raised in ICCAT Circular S25-08854 of 11 September 2025, on deficiencies in reporting and implementation by the Bolivarian Republic of Venezuela in relation to the ICCAT requirements indicated during the 24th Special Meeting of the Commission, held in Limassol, Cyprus 2024.

In this regard, we very respectfully inform you of the following:

1. Rec. 18-07 and Rec. 19-05: Bigeye overharvest (2023: -1.66 t) recurrent white marlin overharvest (2023: -294.65 t) due to negative balance in previous years.

Over the past two years, our fleets have exceeded the catch limits for white marlin and blue marlin established in Recommendation 19-05. This situation, far from being deliberate, is an inevitable consequence of the biological characteristics and distribution of stocks in our national waters, where both marlin species coexist with other target species. For some years now, the Bolivarian Republic of Venezuela has been implementing some control measures for catches of these species. These include the implementation of discards in port and the development and implementation of monitoring and awareness-raising plans for artisanal and industrial fishers through induction and training workshops.

Compliance with discards is currently governed by fisheries regulations and legal provisions (Resolution No. 048-2024 dated 15 November 2024, published in the Official Gazette of the Bolivarian Republic of Venezuela No. 43,033 of 20 December 2024), which encourages the use of these excessive catches for social purposes, being used in social programmes aimed at vulnerable communities, as well as in the network of school canteens and institutions dedicated to social care. Taking into account the value of the bigeye overharvest, it was reviewed and it was noted that this value corresponds to blue marlin and not to bigeye: therefore, Venezuela assumes that it is an error in the form as regards BUM.

2. Annual Report, IOMS and Word, received late: Venezuela had some difficulties in providing a timely response on some issues. However, we are working to correct the shortcomings and to improve reporting. In 2024 and 2025, Venezuela completed all the reporting requirements in the IOMS, and also participated in the training workshops to improve the use of the IOMS platform and information submission, with the objective of optimising all the processes.

3. Rec. 18-05: Billfish check sheet received late: Venezuela has been working to update some pieces of legislation including that related to billfish. In addition, it has been developing monitoring plans, fleet characterisation and training of fishers. The development of these activities had led to some delays in submission of this form, since it requires responses to specific situations that we believed at that time could be resolved. Notwithstanding, we continue to work to improve the reporting of our fisheries, updating the legislation that contain ICCAT measures, and to establish more efficient policies for the conservation of fisheries resources and the food sovereignty of our fishing communities.

4. **Rec. 18-06: Shark check sheet received late:** Venezuela has been working in all its fisheries to improve data reporting and update its legislation. For this reason, it has difficulties to respond timely to some compliance related issues. However, as in the case of the billfish check sheet, the shark sheet requires very specific responses and it was difficult to respond to some questions within the established time. Notwithstanding, Venezuela is committed and is working to improve reporting of the forms and comply with the requirements contained in the Recommendations of the Commission.
5. **Rec. 17-02: SWO-N fishing plan received late:** Venezuela acknowledges and understands that late submission of information causes delays and hinders the Secretariat's work. Notwithstanding, we have had some difficulties for development and timely submission of these requirements. During 2025, the necessary measures were taken so that the information via the different forms reach the Commission by the appropriate deadlines.
6. **Rec. 16-14: Additional information is needed on implementation of the scientific observers programme and reporting. <5% observer coverage and no ST09 received:** Over the past few years, Venezuela has expressed that it has had difficulties to develop and implement the observers programme to enable it to meet the requests of the Commission and comply with the relevant recommendations. Venezuela understands that if it does not have a programme of active observers it cannot comply with some ICCAT requirements contained in its Recommendations. For this reason, we continue to work to find solutions that will enable us to introduce a new programme and for such purpose a resolution establishing the conditions for its strengthening was developed (Resolution DM/N009-2024 published on 3 October 2024 in the Official Gazette of the Bolivarian Republic of Venezuela No. 42,983 of date 11/10/2024). Notwithstanding, our fleet has had some operating and logistical difficulties which has made it impossible to start the trainings of scientific observers, and to coordinate with the captains for implementation and familiarisation with Venezuela's onboard scientific observers programme for ICCAT.

Based on the foregoing, the Bolivarian Republic of Venezuela has created a multi-disciplinary work team, whose objective it is to prepare reports and the necessary analyses to ensure compliance with the submission deadlines established by the Commission.

It should be noted that the Bolivarian Republic of Venezuela and the authorities within the fisheries administration have assumed very responsibly the implementation of management measures aimed to regulate fishing activities, to ensure the sustainability of hydrobiological resources, applying the precautionary criterion, which is based on the best available scientific evidence.

We thank you in advance for your attention in this matter, and please accept the assurances of my highest consideration.

Over the past two years, our fleets have exceeded the catch limits for white marlin and blue marlin established in Recommendation 19-05. This situation, far from being deliberate, is an inevitable consequence of the biological characteristics and distribution of stocks in our national waters, where both marlin species coexist with other target species. In most cases, marlins are not the main species caught, but are caught incidentally, a phenomenon that is difficult for our artisanal and industrial fleets to control. For some years now, control measures have been implemented for catches of these species. These include the implementation of discards in port and the development and implementation of monitoring and awareness-raising plans for artisanal and industrial fishers through induction and training workshops. Compliance with discards is currently governed by fisheries regulations and legal provisions (Resolution No. 048-2024 dated 15 November 2024, published in the Official Gazette of the Bolivarian Republic of Venezuela No. 43,033 of 20 December 2024), which encourages the use of these excessive catches for social purposes, being used in social programmes aimed at vulnerable communities, as well as in the network of school canteens and institutions dedicated to social care.

Dear Sir,

On behalf of Suriname, we acknowledge receipt of your letter dated 11 September 2025 (No. S25-08831) concerning compliance issues related to ICCAT conservation and management measures.

Suriname started targeting tuna and tuna-like species in July 2023 with Surinamese-flagged longline vessels. Since then, we have been actively working to identify ways to implement a National Observer Program for our tuna vessels. However, this process is challenged by limited human and financial capacity. Despite these challenges, we remain committed to establishing the program.

In support of responsible fishing practices, the tuna vessel operators have taken the initiative to install CCTV systems on board their vessels for their own internal monitoring purposes. While this is not yet part of a formal national observer or electronic monitoring program, these efforts contribute to improved oversight of fishing activities and demonstrate the sector's commitment to responsible fishing and compliance with ICCAT objectives. The Directorate of Fisheries can have full access to the CCTV footage.

In December 2024, we expressed our interest to the company Capricorn Fisheries Monitoring cc (Capfish) regarding the provision of observers. Please find attached the requested quotation dated 7 January 2025 from Capfish to assist in the implementation of the National Observer Program for our tuna vessels. The main obstacle in acting upon the quotation has been financial constraints, which have delayed progress. Additionally, the political transition following the general elections held on 25 May 2025, and the recent installation of the new government only two months ago, has contributed to further delays in addressing these matters in a timely manner.

In the meantime, we have also contacted Shellcatch, a company that has already installed systems on ICCAT-registered vessels; their system is therefore compatible with ICCAT's Electronic Monitoring (EM) recommendations. We aim to start the implementation of EM through Shell catch's vessel camera system (virtual observer) by the end of the year.

Suriname appreciates ICCAT's understanding and continued support. We remain committed to fulfilling all necessary requirements and will continue to keep the Commission informed of our progress.
