**2020 INTERSESSIONAL MEETING OF THE ICCAT BLUEFIN TUNA SPECIES GROUP**  
*(Online, 14 – 22 May 2020)*

**Objectives**

1. Review update assessment model set ups and initial diagnostics to ensure that analytical teams can conduct work intersessionally and that we can finalize advice in September;
2. Task a small team to begin to develop the 2020 response to the Commission on growth in farms;
3. Define the reference grid of operating models, the abundance indices for use in CMPs and a method to plausibility weight OMs for the BFT MSE.

The focus of the meetings will be on the Assessment and the MSE. Hence, only papers directly relevant to the assessment and MSE will be scheduled for presentation. Other scientific papers will be accepted but we cannot guarantee that there will be time to present them and they will be presented at the end of the meeting, if time permits. In 2015 the SCRS “proposed that a new deadline for the submission of SCRS documents should be implemented; these documents should be provided in their entirety at least one week before the meeting in which they are to be presented to facilitate their review by participating scientists prior to these meetings”.
