2021 INTERSESSIONAL MEETING OF THE SUB-COMMITTEE OF ECOSYSTEMS

(Online, 5-10 May 2021)

Objectives

Pertaining to ecosystems

In conjunction with the proposal to develop an Ecosystem report card for ICCAT, the Sub-committee will review progress on the inter-sessional exercise to update the status of the 11 ecosystem components that were identified. The indicators described in the assessments are to form the basis for a revised prototype report card that will be presented to the Commission in 2022. As in 2020, the Sub-committee aims to continue the work required to assess the feasibility of and provide information towards implementing ecosystems-based fisheries management (EBFM) in agreement with Resolution 15-11 and Article IV of the recently amended ICCAT Convention.

Pertaining to by-catch

- 1. Continue the ongoing collaborative work related to seabirds and marine turtles.
- 2. Develop a list of by-catch species that are not retained and select the species to be used as indicators.
- 3. Support the development of indicators for the ecosystem report card and the recommendations of other Working Groups (e.g. Billfishes).

- 2. Review the progress on developing an Ecosystem Report Card for ICCAT including the development of status indicators, pressure indicators and reference levels
 - a) Review adequacy of existing indicators against proposed new ones, and progress on the development of methods for screening and validation
 - b) Review development of case studies and ecoregions
- 3. Review how to improve the reporting of the impact of ICCAT fisheries on the ecosystem

Review how the Commission can develop an informal meeting format for the SCRS to work with managers to progress on SCRS-advisory processes that need more involved input from managers [The Sub-committee, which is currently developing the ecosystem report card, needs more working-level feedback from managers in order to provide the Commission with valuable strategic advice and continue developing advice on EBFM implementation options for ICCAT (i.e. in the development and implementation of assessments and management frameworks that incorporate species interactions, fleets interactions, habitats, environmental drivers and climate change into fisheries management).]
- 8. Review and adopt definition of "marine mammal interactions" to facilitate indicator development.
- 9. Review the availability of information on these interactions between marine mammals and ICCAT fisheries.

Pertaining only to By-catch

- 10. Review progress on collaborative work of sea turtle and presentation the next steps.
- 11. Review list of by-catch species that are not retained and retained but are not part of the agreement, their importance to the ecosystem and ICCAT species.
- 12. Effect of the mitigation measures: intra and inter taxa.

Pertaining to Ecosystems and By-catch

- 13. Review feedback received from Species Groups regarding their needs and contributions towards incorporating/developing ecosystem including by-catch considerations and discuss additional mechanisms to effectively coordinate, integrate and communicate ecosystem-relevant research across the ICCAT Species Groups and within the SCRS.
- 14. Review mechanisms for SC-Eco to work across all Species Groups of the SCRS on the issues related with multi-species (e.g. environmental impacts, multi-species trade-offs, integration of ecological considerations into management procedures) similar to the Working Group on Stock Assessment Methods (WGSAM) or the Sub-committee on Statistics.

In order to better organize the meetings, in 2014 the SCRS established deadlines for submitting documents, which were revised in 2015. These deadlines provide the rapporteurs with valuable information to better fit the meeting timetable as well as allow the Secretariat to make the documents available to participants in advance of the meeting. In 2015 and 2019 the SCRS "proposed that a new deadline for the submission of SCRS documents and presentations should be implemented; these documents/presentations should be provided in their entirety at least one week before the meeting in which they are to be presented to facilitate their review by participating scientists prior to these meetings". As such the full documents and presentations for this meeting should be provided to info@iccat.int or nathan.taylor@iccat.int by **28 April 2021**. Documents and presentations provided after the latter deadline will not be accepted unless previously authorized by the Chair. Authors are reminded to closely follow the *Guidelines for Authors of Scientific Documents for the ICCAT SCRS and Collective Volume Series*. Furthermore, the original documents (text, tables and figures) should be prepared in WORD or compatible software.
