2021 INTERSESSIONAL MEETING OF THE ALBACORE SPECIES GROUP INCLUDING THE MEDITERRANEAN ALBACORE STOCK ASSESSMENT

(Online, 21-30 June 2021)

Objectives

In 2021, the Albacore Species Group plans to assess the Mediterranean stock (last assessed in 2017) and update the management recommendations for this stock.

As for the Northern stock, the tentative adoption of a long-term Management Procedure (MP) is scheduled in 2021 (Rec. 20-04). The Group will also provide feedback to Panel 2 on the exceptional circumstance indicators, and will use these to determine if exceptional circumstances might be occurring. In addition, the Species Group will start working on a new reference case using Stock Synthesis, to be used in future benchmark assessments and revision of the uncertainty grid.

For all three stocks of albacore, the WG will revise research activities to develop updated research plan.
