The main albacore related objectives for 2023 are to conduct stock assessment for the North stock (as required by Rec. 21-04), iterate the management procedure, start developing a new MSE for the northern Atlantic stock, and continue with the research for all three stocks as defined in the Albacore Year Program (ALBYP).
