According to the [Rules of Procedure for the Administration of the Special Meeting Participation Fund](#) adopted at the 2020 Commission meeting, requests should be sent to [ICCAT-Travel@iccat.int](mailto:ICCAT-Travel@iccat.int) at least **75 days** in advance to the start of the meeting:

**23 March 2023** CDS  
**24 March 2023** IMM

Requests for financial assistance cannot be accepted after that date. As has been the case previously in similar situations when several meetings of the same subsidiary body of the Commission were scheduled back-to-back, and aiming at the best use of the Meeting Participation Fund (MPF), only one delegate per Contracting Party may request financial assistance. Therefore, if attending more than one of the meetings, the same nominee should be nominated for all meetings for which assistance is being sought. All the information related to the [ICCAT Special Funds for participation in ICCAT meetings and capacity building](#) is available on the ICCAT website. It is highly recommended to visit this web page in advance and to strictly follow the protocols. In particular, it is necessary to fully complete the invitation form.

In order to organize the hybrid meetings in advance of the session, in particular, regarding the number of in-person participants, you are kindly requested to send to the Secretariat a list of delegates who will participate in the meetings by **26 May 2023**. Any late submission of the official delegation may cause a delay in providing access to participants to the meetings.
