The general objective of this workshop is to improve the monitoring and reporting of artisanal tuna and tuna-like fisheries, namely of billfishes, small tuna and tropical tuna artisanal fisheries statistics in the Caribbean region. To achieve this objective, preliminary work must be carried out by the statistical correspondents prior to the workshop. It is expected that each statistical correspondent engaged in the workshops submits an SCRS document with a **detailed description of the current national fisheries data collection program**.
