As has been the case previously in similar situations when several meetings of the same subsidiary body of the Commission were scheduled back-to-back, aiming at the best use of the Meeting Participation Fund (MPF), only one delegate per Contracting Party may request financial assistance. Therefore, if attending more than one of the meetings, the same nominee should be nominated for all meetings for which assistance is being sought, and the deadline for receipt would be the earliest of those indicated above. It is highly recommended to visit this web page in advance and to strictly follow the protocols. In particular, it is necessary to fully complete the invitation form.
