First Intersessional Meeting of Panel 1 on Tropical Tuna MSE
(online, 30 March 2026)

The *Recommendation by ICCAT replacing Recommendation 24-04 on a Candidate Management Procedure for western Atlantic skipjack tuna (Rec. 25-02)* calls for the SCRS to provide scientific guidance to the Commission for the development of the exceptional circumstances protocol for the adopted SKJ-W MP, for review and adoption by the Commission at its 2026 Annual Meeting. In this meeting of Panel 1, the SCRS will present its workplan and any updates on the progress of this work. The *Resolution by ICCAT on interim operational management objectives for Atlantic bigeye tuna, yellowfin tuna, and the eastern stock of skipjack tuna (Res. 24-02)* provided interim management objectives to guide the SCRS in advancing its work on the Tropical Tunas Multi-Stock MSE, covering the Atlantic yellowfin tuna, Atlantic bigeye tuna, and the eastern Atlantic skipjack stock. In this meeting, the SCRS will report on the progress on the Multi-Stock MSE and the workplan. In particular, the SCRS is seeking feedback from Panel 1 on the suitability of the current approach in addressing Commission conceptual objectives, and on whether or not Panel 1 wishes to modify or add to the interim operational management objectives included in [Res. 24-02](#).
