The meeting will review new biological information, catch and fisheries statistics (including discards), indices of abundance, and auxiliary information for the assessment models. In addition, relevant matters related to new gear types (trap line), discarding estimation, Swordfish Year Program (SWOYP) results, and the North Atlantic swordfish Management Strategy Evaluation (MSE) development will be discussed.

3. Language

Following the recommendations from the SCRS and the decision of the Commission in 2025, language interpretation will be provided during the meeting. Participants are encouraged to take advantage of native language opportunities and use video during interventions to facilitate the interpreter's task.

4. Call for scientific papers and presentations

Participants are encouraged to submit relevant scientific papers/presentations. In advance of submitting those, authors shall request the SCRS reference to the meeting Chair, Kyle Gillespie and the ICCAT Secretariat contact. After clearance from the meeting Chair, the ICCAT Secretariat will assign a specific SCRS reference and inform the author(s).

Following the latest SCRS deadlines for the submission of SCRS documents and presentations, for this meeting, they should be provided to info@iccat.int and/or nathan.taylor@iccat.int by 13 March 2026. Documents and presentations provided after the latter deadline will not be accepted unless specifically authorized by the Chair. Authors are reminded to closely follow the new Guidelines for Authors of Scientific Documents for the ICCAT SCRS and Collective Volume Series. Furthermore, the original documents (text, tables, and figures) should be prepared in WORD or compatible software.

5. Provision of data

CPCs are requested to submit updates of Task 1 and Task 2 data already reported (up to the year 2024) at least two weeks before the start of the meeting (6 March 2026).

Individual standardized catch per unit effort (CPUE) indices until 2024 should be provided for the southern Atlantic and Mediterranean stocks. Since the Working Group on Stock Assessment Methods (WGSAM), established standard criteria to evaluate standardized catch rates, it is recommended that authors of documents on standardized CPUEs follow the ins t ructions defined by the WGSAM describing the information required to facilitate the appropriate construction and evaluation of CPUE series.
