SECRETARIAT REPORT TO THE PERMANENT WORKING GROUP FOR THE IMPROVEMENT OF ICCAT STATISTICS AND CONSERVATION MEASURES (PWG)

ICCAT Secretariat

NOTE: This report is based on information and submission transmitted until **13 October 2017**. Any information received after that deadline will be brought to the attention of the PWG Chair. This additional information shall not be translated.

1 Statistics documents and bluefin catch documentation programmes

A comparison between statistical documents data (bi-annual swordfish and bigeye reports) and Task I nominal catch data is provided in document **PLE_105/2017** (Tables 22 and 23 for swordfish and bigeye, respectively). Trade data in accordance with Rec. 06-13 are contained in Annex 1 of **COC_303/2017** (electronic version only).

- Validation and other information required

Validation information on institutions and people authorised to validate the ICCAT statistical document is published on a password protected website: http://iccat.int/en/SDPsummary.asp

In accordance with Recs. 01-21 and 01-22, bi-annual Statistical Documents (SD) and/or Re-export Certificates (RC) of swordfish (SWO) and bigeye (BET), for the second semester of 2016 and first semester of 2017, were received by the Secretariat from the following CPCs: Canada, China, Côte d'Ivoire, EU (all flags combined), Japan, Korea, Norway, Senegal, Turkey, USA, Chinese Taipei and Singapore, as summarized in Table 21 of **PLE_105/2017**. Responses to the Secretariat's requests for clarifications from Ghana and Trinidad and Tobago have not yet been provided; the data of their bi-annual SD reports will be used next year.

These reports reveal that some quantities of these two species continue to be imported from unknown areas making it difficult to distinguish the origin of the fish, and make the comparison with Task I data impossible. They show also that imports continue to be made from fishing flags whose validation information has never been submitted to the Secretariat. To date, no validation information has yet been received from Tanzania, although Japan continues to import SWO from this country. Other CPCs have also had some imports from Tanzania, namely Chinese Taipei (SWO and BET) and the US (SWO). The Secretariat has again requested this information from Tanzania. Papua New Guinea has had some BET exports to EU-Spain, but no validation information has yet been received. The Secretariat has requested this information from Papua New Guinea. In addition, it should be noted that the Secretariat requested from Guyana information on its validation authorities and it has been communicated for the two species.

It should be noted that new importing countries of these two species have been detected, namely Burkina Faso (BET), Israel (BET), United Arab Emirates (SWO), EU-Sweden (SWO), EU-Germany (BET and SWO), EU-Belgium (SWO) and Saudi Arabia (SWO). The Secretariat will contact the four that are not ICCAT Contracting Parties, Entities or Fishing Entities, as stipulated in paragraph 11 of Recs. 01-21 and 01-22, in order to request their cooperation as well as submission of statistical documents data reports.

- BCD annual reports

In accordance with Rec. 11-20, these reports have been published on a password protected web site at: http://www.iccat.int/en/BCD.asp. No report has been received from EU-France, EU-Italy and EU-The Netherlands.

- BCDs and BFTRC submission and processing

The Secretariat received, between 17 October 2016 and 13 October 2017: 2 paper BCDs (both from 2016), 910 splits (approximately 90% from 2015) and 730 Bluefin Tuna Re-Export Certificates (BFTRC). The information from these documents is published on the web page at: http://www.iccat.int/en/BCD.asp

- Implementation of the eBCD system

The eBCD Technical Working Group (TWG) met once in 2017, but no report from the meeting is available. As the Secretariat did not receive any technical specifications or confirmation of the developments requested by the TWG, no request for additional development was made to TRAGSA. Therefore, some issues remain pending. For example, the Secretariat has received from different CPCs the request that it be possible to download from the eBCD system the annual report with the dates established in Rec. 11-20, paragraph 34, i.e. 1 July to 30 June. This would involve a change to the system and it has not yet been possible to request this change from the Consortium. Another new function was requested at the Bluefin Tuna Data Preparatory Meeting in March 2017 concerned with the inclusion in the eBCD system of spatial geolocation (lat/lon) of fishing operations.

The system has been in use since 1 May 2016 with some specific and temporary provisions, in compliance with Rec. 15-10. Additional development and future user support/maintenance might require more funding over and beyond the amounts already set aside from the Working Capital Fund. A proposal from the TWG Chair on the funding of the system is contained in document **STF-207/17**.

The report of the Consortium concerning the use by the Contracting Parties of the eBCD system is presented in document PWG-403 /17.

The Secretariat, with the profile of ICCAT Administrator in the eBCD system, would like to make the following observations:

Since it is the second year, fewer requests by CPCs for assistance with different functions of the application were registered compared to 2016, as well as with editing and correction of information that they recorded. The Secretariat and TRAGSA continue to assist CPCs with tasks which their administrators are authorised to carry out. This year, in particular, there have been a large number of requests for registration of validators. EU-Italy is a case in point; they requested more than one thousand new users with this role, when CPCs can upload their request for new validators using the form that can be downloaded from the eBCD, before the Secretary, in turn, requests the issue of digital certificates from TheServerLab.

In terms of the quantity of digital certificates, taking into account that this year 1343 new ones have been requested and 258 have been renewed, the Secretary will need to know an approximate estimate of the number of certificates envisaged when the next budget is negotiated with the consortium.

CPCs are complying with Rec. 15-10, i.e. in 2017, all purse seine catches were recorded directly in the electronic system, except in the cases stipulated in paragraph 6 of Rec. 15-10. These cases involving a technical issue are published on the website: http://www.iccat.int/en/eBCDprog.asp

The number of eBCDs recorded in the eBCD system from 01/11/2016 to 16/10/2017 is 12231 for a total quantity of 23405 t of bluefin tuna. There have been 1543 paper BCDs which have been converted into eBCDs. No BFTRC has been converted. The number of eBFTRCs recorded in the eBCD system from 11/01/2016 to 16/10/2017 is 398. 17 of these BFTRCs had not been validated at the time of writing this report, amounting to a total of 77 t.

2 ICCAT Regional Observer Programmes

Document **PWG_402/17** contains the report on ICCAT Regional Observer Programme on transhipment, and document **PA2_601/17** a report on the implementation of the ICCAT Regional Observer Programme for eastern Atlantic and Mediterranean bluefin tuna (ROP-BFT). The consortium has requested clarification on some issues and these have been directed to Panel 2.

The Secretariat would like to raise the need for the Contracting Parties involved in the BFT-ROP programme to inform their farms that the BFT-ROP observer has to sign the farming and/or harvest information section in the eBCD while deployed in the farm, before the government validation, and not afterwards. If there are some changes several months later due to the stereoscopical data, the change can be registered after in the eBCD by the government authority. This issue is raised by the Secretariat who has had to sign on behalf of some BFT-ROP observers several eBCDs several months after the deployment at the farm.

3 At-sea and in-port transhipment requirements

CPC reports on transhipment (at sea and in port) are contained in Annex 1 and Annex 2 to **PWG_402/17**, Appendix 2 of which contains the comprehensive reports assessing the content and conclusions of observer reports.

4 Rules for chartering and other fishing arrangements

The summary reports on chartering in 2016 submitted by Namibia and South Africa are contained in Appendix 2 to COC_303/17. The information received by the Secretariat, in accordance with paragraph 13 of Rec. 13-14 is presented in Table 11 to COC_303/17.

In accordance with Rec. 14-07, the summary of Access Agreements reported by CPCs is available in Table 12 to COC_303/2017.

5 At-sea vessel sighting and inspection programs

As far as inspection programs are concerned, the Secretariat has prepared a summary table with the main findings of the inspections reports carried out under Rec. 14-04, Annex 7 (available as Table 9 to COC_303/2017). The European Union (EU) has come across four inspections on Tunisian vessels that have concluded with a statement of potential non-compliance. The information submitted by the EU and Tunisia is presented in document COC-307/17.

In addition, Turkey informed the Secretariat of two cases of non-compliance by two EU-Greece vessels of Rec. 14-04, Annex 7 and Rec. 16-05, Annex 1. The information has been transmitted to the European Union. At the time of writing this report, that information had been circulated to Contracting Parties in the draft IUU list and is pending its continuance on or removal from the provisional IUU list.

6 Port inspection schemes and other port State measures

The Recommendation by ICCAT for an ICCAT Scheme for Minimum Standards for Inspection in Port [Rec. 12-07] imposes several obligations on CPCs.

The list of ports into which foreign vessels may enter, has been published on http://iccat.int/en/Ports.asp together with contacts and prior-entry request times.

In accordance with paragraph 20 of Rec. 12-07, the Secretariat has received copies of inspection reports from Cabo Verde, Morocco, Namibia, Senegal, South Africa and Tunisia. The Secretariat has not posted these reports on the ICCAT web site, as no infractions were reported. South Africa, which is a Contracting Party to both ICCAT and IOTC is using the electronic Port State Measures reporting system implemented by IOTC. Since mid-2017, the IOTC has kindly incorporated the relevant ICCAT referentials into their system to allow South Africa to use this system to also report to ICCAT. The system is working well and 32 reports have been received from South Africa through ePSM since July 2017.

Rec. 12-07 requires CPCs to inspect at least 5% of landing and transshipment operations in their designated ports made by foreign fishing vessels, and stipulates that the port CPC shall transmit a copy of the inspection report to the ICCAT Secretariat no later than 14 days following the date of completion of the inspection. The Working Group of Port Inspection Experts met in Madrid, 9-10 October 2017, to consider ways to provide assistance to developing States to implement this measure. The findings of this group are contained in document **PWG-406/17**. The PWG, followed by the Commission, are requested to endorse the questionnaires developed by the Working Group, in order to proceed to the next steps.

Request for clarification: Given the requirement in Rec. 12-07, paragraph 20 to receive copies of all inspection reports, the Secretariat would appreciate guidance regarding what should be done with the reports which do not contain infractions.

7 Vessel registration requirements and CLAV requirements (Consolidated list of authorised vessels)

Following the recommendations made by the tuna RFMOs on the Consolidated list of authorised vessels (CLAV, details contained in document **PLE_105/17**), the ICCAT vessel database contains the IMO number (or any other international registration number), provided that it is supplied.

For the current state of the ICCAT Record of Vessels, please see the summary contained in **Table 1**. The ICCAT Record of Vessels database is now an integrated system that manages:

- a) Any information from a total of eleven ICCAT vessel authorisation lists: the positive list LOA>=20M [P20m], the four new vessel lists whose authorisations are associated with the P20m list (North and South Atlantic swordfish: SWOn and SWOs; North and South Atlantic albacore: ALBn and ALBs), the Mediterranean swordfish vessels list [SWOm], the new Mediterranean albacore vessels list [ALBm], the E-BFT catching vessels list [BFTc], the "E-BFT"-other vessels list [BFTo], the carrier vessels list [Carr] and the tropical fishing vessels list [Trop]);
- b) Vessels subject to chartering agreements;
- c) Longliners [LSPLVs] authorised to tranship to carrier vessels;
- d) The list of vessels that have carried out fishing operations in the previous year in the TROP, SWOm and BFTc fisheries (information also shared with Task I fishing fleet characteristics, used by the SCRS to manage the remainder ICCAT fisheries presented in Table 1 of PLE-105).

The inclusion in 2017 in the ICCAT Record of Vessels of five new Authorisation Lists (VRL) has increased the number of active vessels to 28000. The number of active vessels in the same period in 2016 was 8797.

Reporting issues still persist, such as incomplete reporting of vessel characteristics, in particular, those identified as mandatory. **Table 2** provides detailed information by CPC in this regard.

The 50958 vessels registered in the ICCAT vessels database still lack essential information (despite the significant improvements in 2017), such as, in particular, the National Registration Number (NatRegNo), the International Radio Call Sign (IRCS), type of fishing vessel (ISSCFV), type of fishing gear (ISSCFG) and tonnage. For around 21% and 17% of vessels, there is no information respectively on the vessel owners and operators. In some cases, it appears that the information is not reported because of the national laws on confidentiality of some CPCs.

The figures contained in **Table 3** show that all the 3941 vessels (3826 in the positive lists and 115 in the carrier/support vessels list) with a length of 20 metres or greater that are active in one or several of the eleven ICCAT Record of Authorisation Lists, now comply with paragraphs 5bis/5tris of Rec. 13-13, as long as they have been allocated an International Registration Number (IMO, LRN, JUS or WOD). They are distributed as follows: 44% IMO, 1% LRN, 30% JUS, and 25% WOD. Only for two active vessels this information is "unknown".

Since the Commission authorised the Secretariat to deactivate each vessel whose authorisation/s have expired, by more than 45 days, in one or several lists, a number of vessels with expired authorisations are regularly moved to the ICCAT Record of Inactive Vessels. This rules does not cover carrier vessels for which the Secretariat requests, whenever it is necessary to do so, confirmation from CPCs with vessels with expired authorisations (>= 45 days).

Requests from the Secretariat:

Duplication of vessels:

Mindful of the integrity of the ICCAT Record of Vessels, the Secretariat continues to request collaboration from CPCs each time duplications of vessels are identified. These duplications are essentially caused by inactive vessels on the ICCAT Record. CPCs, when making submissions in relation to their different vessels (for modification, updates or inclusion/reactivation) are not mindful of their lists of inactive vessels. These situations could affect the quality of the ICCAT vessel database (during 2017, detected an increase in the number of possible vessel duplicates), in relation to which great efforts have been made in recent years in collaboration with the CLAV and other organisations (RFMOs and others).

For this purpose, the Secretariat requests assistance from the Commission so that CPCs provide more support, in particular by paying attention to and using the lists of inactive vessels which are extracted from the ICCAT Record and provided to them on request. It is the best way to eliminate vessel duplicates each time they are identified by the Secretariat. If we ignore what is happening with the inactive vessel lists, the growing problem of duplications will unfortunately undermine the ICCAT Record of Vessels, and, all the databases receiving automatically this data (CLAV and eBCD systems).

Vessel characteristics:

Those which are missing should be completed, in particular, the National Registration Number (NatRegNo), the International Radio Call Signs (IRCS), the fishing vessel types (ISSCFV), the fishing gear types (ISSCFG) and tonnage.

The length overall (LOA) and tonnage (GRT/GT) fields should be reported rounded to one decimal (maximum two).

Vessel names should be in Latin script as stated in the "Guidelines for submission of data and information required by ICCAT": http://iccat.int/Documents/Comply/Guidelines ENG.pdf

The integrity of the ICCAT Record of Vessels depends on the following three conditions:

- 1. Completeness of the information submitted on vessels,
- 2. Mandatory information that is missing,
- 3. Compliance with the stated rules on deactivation of vessels with expired authorisation periods.

Table 1 of Annex 4 to COC_303/17 gives summaries of the Previous Year (2016) reporting lists (BFT-E, TROP, SWO-M) in number of vessels by flag CPC and list. The three lists have now the same deadline as Task I (by July 31 each year).

Table 1 of **PLE_105/17** summarises the 2017 data reporting status by flag CPC and ICCAT fishery (BFT-E, SWO-M, TROP, and others, with the respective deadlines in force).

8 Vessel Monitoring System requirements

Information on the VMS messages received at the Secretariat are contained in document COC_303/2017. To date, the system has been working well but is now ten years old and an update to the hardware, as well as the maintenance contract, will be required in 2018 in order to ensure continued service. This issue may require referral to STACFAD.

9 Flag State responsibilities

Rec. 03-12 does not require the submission of specific information. Within the framework of the ROP programme for transhipment, Contracting Parties are sometimes informed of marking and identification not correctly displayed on the LSPLV (refer to document **PWG_402/2017**, Appendix 1).

10 Review and establishment of the IUU vessel list

The WCPFC informed the Secretariat that compared to its 2016 IUU list, its 2017 IUU list had no changes. This information was circulated by the Secretariat to all CPCs. The Secretariat requested their 2017 IUU lists to IATTC and to IOTC. IATTC informed that there were no change since the IUU 2014 list and IOTC reported that there were additional vessels since 2016. The IOTC IUU list, as well as its supporting information, was transmitted to the CPCs for comments before 7 October 2017. The draft ICCAT IUU list, without the inclusion of the new IUU vessels listed by IOTC, was distributed to CPCs for comment. Compared to the ICCAT 2016 IUU list, the draft IUU list includes two vessels from EU-Greece sighted by Turkey during an inspection under the ICCAT Scheme of Joint International Inspection. The PWG will also have to decide if, as requested by Bolivia, three vessels (KIM SENG DENG 3; YI HONG 106, YI HONG 116) listed in the IUU list in 2015 as having Bolivian flag can be listed on the ICCAT IUU list as "unknown flag State".

Due to the late submission of some information, the Secretariat has not applied the procedure of the intersessional delisting (no sufficient calendar days before the annual meeting) and has given a deadline for CPCs comments in advance of the annual meeting to be able to present a provisional IUU list to the PWG. This leads to the following request from the Secretariat:

Request for clarification:

In the case of a request for intersessional removal of a vessel from the IUU list, paragraph 19-20 of Rec. 11-18 provides that "If the result of the exercise indicates that there is a majority of the Contracting Parties in favour of removal... the Chairperson of ICCAT... will communicate the result..." and the "ICCAT Executive Secretary will take the necessary measures to remove the vessel" from the ICCAT IUU List: does this require that a majority of Contracting Parties affirm their support in a response to the Secretariat, or should no response (provided that the Contracting Party confirms receipt of the request) be treated as indication that the Contracting Party is "in favour of the removal"?

The provisional list, for consideration and possible adoption by the Commission, is contained in document **PWG_405/17** with some background information provided by WCPFC and by IOTC.

11 Other issues

Related to point 7 of this report, concerning the duplication of vessels, and to point 10 on the establishment of the IUU vessels list by the Secretariat, the Secretariat would like to raise a possible loophole in the vessel registration and in the IUU listing procedure. This summer a problem of vessel identification has been raised by the European Union and has led to the arrest in port of one vessel because its IMO number was the same as the IMO number of a vessel on the IUU list since 2006 (with another name). The Contracting Party of the vessel arrested informed the European Union that these were two different vessels. However, it raises a problem of comprehensive identification of vessels being listed in the IUU list as well as the need to better follow-up the changes made by vessel's owner of IMO number.
