**EXPLANATORY NOTE ON THE ICCAT BUDGET
FOR FINANCIAL YEAR 2019 (REVISED)**

In accordance with the provisions of Article X.1 and X.3 of the ICCAT Convention and of Article 2 of the Financial Regulations, the Secretariat must submit to the Commission for consideration and adoption the revised draft budget for 2019. The Commission adopted at its 25th Regular Meeting (Marrakesh, Morocco, 14-21 November 2017) the budget for 2018 and 2019.

The expenses budget for 2019 does not include any change with respect to the budget that was originally approved by the Commission (Marrakesh, Morocco, 14-21 November 2017).

As to the revenues budget for 2019, the only change it includes is the United Nations exchange rate for the month of October.
