GHANA RESPONSE ON CAPACITY LIMITS AS REGARDS TO RECOMMENDATION 16-01

Ghana as member of ICCAT is enjoined to conform to all regulations and recommendations for the judicious management of shared fishery resources in the Atlantic Ocean.

Ghana was noted in the early 2000's to have increased her capacity limits of her vessels in terms of numbers and GRT against recommendations based on SCRS stock assessments conducted earlier on the principal tuna species. In the said recommendations, Ghana was to reduce her effort exerted in the fishery by a downward reduction of fishing units in terms of the numbers which also invariably means her gross registered tonnages.

Since 2012, Ghana has cautiously delisted over 15 of her vessels to reduce the excessive capacities exerted on the fishery (See Table 1 below).

All of these vessels which are obsolete are delisted from our register at the Ghana Maritime Authority. A few of such vessels are still in operation which in future may be replaced.

Recommendation 16-01, paragraph (12)(c) provides as follows:

"Ghana shall be allowed to change the number of its vessel by gear type within its capacity limits communicated to ICCAT in 2005 on the basis of two baitboats for one purse seine vessel. Such change must be approved by the Commission. To that end, Ghana shall notify a comprehensive and detailed capacity management plan to the commission at least 90 days before the Annual meeting".

In pursuant of the above provision, Ghana has maintained her fleet size for the past 5 years at 17 purse seiners and 20 baitboats within her limits and has been monitoring her catches within allocated quotas. *Ghana thus, in compliance with the provisions in Recommendation 16-01 (12) (c) invokes the said provision, effective 2019* to replace 2 of her old decrepit baitboats for 1 purse seine of the same capacity in terms of the gross registered tonnage.

It is to be placed on record that in 2011, Ghana submitted a comprehensive plan and in pursuant of the above a revised comprehensive management plan shall be submitted in due course.

The Plan will, as usual intensify:

- reduction in the incidence of overharvest of species especially the bigeye tuna;
- monitoring systematically levels of catches especially under FADs on quarterly basis by all fishing companies;
- enforcement of Observer programmes;
- the use of electronic devices (cameras) under the ABNJ project sustainably;
- strengthening MCS operations, among other control measure.
