

## EXPLANATORY NOTE ON THE EBCD SYSTEM BUDGET FOR FINANCIAL YEARS 2020 AND 2021

In accordance with the provisions contained in Article X.1 of the ICCAT Convention and in Article 2 of the Financial Regulations, the Secretariat must submit the draft budget for the next two financial years i.e. 2020 and 2021 to the Commission for its consideration and adoption, including the eBCD budget.

The purpose of this note is to outline the proposed draft budget for 2020 and 2021, how it is structured, the line items of the different items as well as the impact on additional annual contributions by Commission members that catch and/or trade Atlantic bluefin tuna.

### 1 eBCD System expenses budget proposal

The eBCD System expenses proposal that has been prepared by the Secretariat amounts to €635,000.00 for financial year 2020 and to €340,000.00 for financial year 2021.

The proposal for 2020 is comprised of the following items:

- **Support and maintenance of the electronic Bluefin Tuna Catch Document (eBCD) System:** The Secretariat has requested a budget of €275,000.00. This item includes the following activities related to infrastructure: Infrastructure, SSL Certificate renewal, Infrastructure Administration and Support in AWS, Set up AWS security services (one-off cost), Infrastructure in AWS: Security services and AWS business support 2019. In addition to these activities, it also includes the following support, maintenance, project management and analysis activities: One Year User support 8x5 and Maintenance of the web application and Project Management and Analysis of new requests.
- **Developments in the web application ("Flexible" allotment): Development activities requested by the Working Group (WG).** A budget of €200,000.00 has been requested to cover the following activities:
  - a) Adapt the system to allow access to NCPs. The Secretariat has estimated a cost of this activity at €50,000.00, until the contribution is received from TRAGSA.
  - b) Web services. As above, a cost of €50,000.00 has been estimated, since receipt of the budget from TRAGSA is pending.
  - c) Other activities not yet defined. The estimated amount projected for new developments will be at least €100,000.00. This amount will be modified in line with amendments to the text of Rec. 18-02, to adjust the cost of the new development to the requirements of future recommendations.

- **Salaries:** The Secretariat has requested that the Commission approve two new appointments within the eBCD budget, to carry out the development of the new activities as well as system support and maintenance. In 2012, the consortium formed by TRAGSA, S.A and The Server Labs, S.L. was contracted to develop the software for implementation of the eBCD system and since 2014, the contract has been extended on a yearly basis to continue the support, development and management, as well as software maintenance and user support. Given that this system is constantly changing due to ICCAT provisions, the Secretariat considers that, in an effort to reduce costs, the best option is to have a team at the Secretariat that performs the work currently carried out by TRAGSA. If the Commission approves these appointments, the transition from TRAGSA to ICCAT will foreseeably take one year. Subsequently, in 2021, a third person would need to be hired to fully disconnect from TRAGSA and to provide user support 5 days a week.

In 2021, the expenses budget would amount to €340,000.00 and it would comprise the salaries of three workers and the expenses associated with infrastructure which will foreseeably be around €100,000.00.

## 2 eBCD System budget draft proposal

The additional annual contributions to the eBCD System budget for 2020 and 2021 are set out in Tables 3 and 5, respectively, in accordance with Regulation 4. 1 bis – Provision of Funds of the Financial Regulations. €200,000.00 have been deducted from the expenses proposal for financial year 2020 contained in item 1 that had been charged to Chapter 12 of the 2019 ICCAT budget. Therefore, the eBCD revenue budget would amount to €435,000.00 for 2020 and €340,000.00 for 2021.

The 2020-2021 draft proposal has been estimated based on the following data.

- (i) Eastern and western bluefin tuna catch figures (in t) of Commission members that catch and/or trade Atlantic bluefin tuna for 2016 and 2017 from document COC-304D/2018. (The year 2015 has not been taken into account because there are no data available for items (ii) and (iii)).
- (ii) Total number of trade transactions of the Contracting Party in the eBCD system for years 2016 and 2017, provided by TRAGSA.
- (iii) Total volume imported of Atlantic bluefin tuna of the Contracting Party, as registered in the eBCD system for 2016 and 2017, provided by TRAGSA.

Finally, it should be noted that these contributions will be revised at the 2019 Commission meeting to update the United Nations exchange rate used for the calculation (the exchange rate of September 2019 has been used).
