EXPLANATORY NOTE ON THE ICCAT BUDGET FOR FINANCIAL YEARS 2022 AND 2023

In accordance with the provisions contained in Article X.1 of the ICCAT Convention and in Article 2 of the Financial Regulations, the Secretariat must submit the draft budget for the next two financial years i.e. 2022 and 2023 to the Commission for its consideration and adoption.

The purpose of this note is to outline the proposed draft budget for 2022 and 2023, how it is structured, the line items of the different items as well as the impact on the contributions of ICCAT members.

In preparing the budget for the next two years, the comments have been taken into account of the ICCAT performance review panel, Recommendation #130, and the Commission's decision to continue regularizing activities that were being financed through the Working Capital Fund in the ICCAT budget so as to reduce extra-budgetary expenses.

To continue strengthening the financial situation, it is proposed that the Contracting Parties make an effort to increase their budgetary contributions.

1 Budgetary expenses proposal

The proposal prepared by the Secretariat for financial year 2022 contains an increase of 8.42% with respect to 2021, as well as a 5.65% increase for 2023 with respect to 2022, as shown in **Table 1**.

The chapters and subchapters with changes are detailed below:

- **Chapter 1 - Salaries:** In the draft budget submitted, this chapter contains an increase of 14.21% with respect to 2021. In addition to the salary scale update published by the ICSC for existing staff and 20,000.00 euros for Secretariat staff training to continue with actions focused on improving the abilities and skills of the staff to increase their participation and efficiency, this amount also includes two new positions.
 - The first request corresponds to the position of **Publications Editor**. The main task will be to supervise preparation of all Commission publications: Annual Reports, Collective Volume of Scientific Papers, documents and books prepared by Secretariat staff, etc., including editorial corrections, reviews, and adoption of reports, in addition to ensuring that SCRS and Commission meeting documents are translated, copied and distributed in a timely manner and providing translation support as required. The Assistant Executive Secretary currently carries out the majority of these tasks, which he combines with his role as Scientific Coordinator, with the assistance of the Executive Secretary. However, due to the increase in the number of meetings in recent years and the corresponding and very significant increase in the number of documents to manage, review, edit and

publish, it is now impossible for him to perform this task alongside his other management responsibilities. In addition, the Secretariat seeks to maintain the high standards of ICCAT publications, prevent errors and ensure that documents are published within the established deadlines. The creation of this position, similar to one that previously existed within the Secretariat, is therefore considered essential. It would be classified in the P3 category and would free up the Assistant Executive Secretary to enable him to focus on all other tasks under his responsibility, including the coordination of ICCAT scientific staff, business between the Secretariat and the SCRS, research and capacity building programmes developed by the Secretariat, topics of scientific interest common to other closely related organisations; preparation of SCRS meetings, and the management of Commission meeting documents and the ICCAT website.

- The second request corresponds to the position of **Compliance Department Technical Manager**. Due to the constant increase in compliance requests, it is necessary to increase the department's development and programming capacity. Consequently, it is necessary to hire a new member of staff to process data and provide general assistance, with good writing skills and a native English speaker. In the case of adoption of new Recommendations which require additional tasks, the Secretariat strongly urges the Commission to provide it with the human resources necessary to carry them out.
- **Chapter 2 – Travel:** The Secretariat proposes to increase this chapter by 100.00% with respect to 2021, so as to resume field activities, following their interruption due to the COVID-19 pandemic. Following the transfer of half of the funds of this chapter to Chapter 3 – Commission Meetings – in the 2021 budget, the amount in this chapter has been restored to pre-pandemic levels.
- **Chapter 3 – Commission meetings (annual):** The Secretariat proposes an increase of 9.29% to continue regularising this chapter, which will be updated in the next biennial period to cover the actual cost of the ICCAT annual meeting.
- **Chapter 4 – Publications:** A reduction is proposed of 30.78% with respect to the 2021 budget to adjust the amount to the decrease in the number of paper publications and the associated cost.
- **Chapter 8 – Coordination of research:**
 - a) **Salaries:** In the draft budget submitted, this subchapter contains an increase of 2.73% with respect to 2021, following adjustment of the budget to the projected costs for 2022 and 2023.
 - b) **Travel to improve statistics:** An increase of 100% with respect to 2021 is proposed to adjust the budget to the pre-pandemic amount, after half of the funds of this chapter were transferred in 2021 to Chapter 3 – Commission Meetings.
- **Chapter 9 – Services requiring specialist external consulting:** The Secretariat proposes an increase of 29.31% with respect to the 2021 budget. This increase will cover the costs of the contract signed with an external company to provide support related to cybersecurity management, information security and regulatory compliance, through implementation of a plan to integrally adapt cybersecurity management at ICCAT, and will cover the other services that may require specialist external consulting, such as legal consultancy, quality management projects, etc.
- **Chapter 11 – Strategic Research Programme:** In 2021, it was decided to increase this Chapter by 250,000 euros after transferring a portion of the funds of Chapter 13.b) – Special meeting participation fund due to the lack of meeting costs as a result of the pandemic. For the 2022 and 2023 budget, it is proposed to keep Chapter 11 at the same level as in 2021 and gradually regularise the special Meeting Participation Fund over coming financial years, as the necessary funds projected for 2022 and 2023 are below the amount transferred in 2021. Lastly, we would

like to point out that Chapter 11 must continue to be regularised in future budgets until a level is reached that would cover the entire demand of activities required by the SCRS.

- **Chapter 13** – The following increases are submitted for approval:
 - a) **Travel by ICCAT and SCRS Chairs:** An increase of 100.00% with respect to 2021 has been presented to adjust the budget to the pre-pandemic amount, after half of the funds from this chapter were transferred to Chapter 3 – Commission Meetings in 2021.
 - b) **Travel by ICCAT officers (developing ICCAT Contracting Parties):** An increase of 100.00% with respect to 2021 has been presented to adjust the budget to the pre-pandemic amount, after half of the funds of this chapter were transferred to Chapter 3 – Commission Meetings in 2021.

2 Budgetary revenue proposal

The annual contributions to the budget for 2022 and 2023 are shown in **Tables 3** and **5**, respectively, in accordance with Regulation 4 – Provision of Funds of the Financial Regulations, and taking into account the expenses proposal contained in item 1.

The 2022-2023 draft budget has been estimated based on the most recent data available to the Secretariat. In relation to the financial possibilities of the member countries, the GNP per capita for 2019 has been used, published in the Handbook of Statistics 2020 of the UNCTAD. Regarding the data related to catches and canning the data used are those reported by the Contracting Parties in response to ICCAT Circular 1743-21, of 17 March 2021. For those parties that have not reported data, the Secretariat has used the most recent data.

Finally, it should be noted that Contracting Party contributions will be revised at the 2021 Commission meeting to incorporate other possible changes in panel membership, if any, and to update the United Nations exchange rate used for the calculation (the exchange rate of July 2021 has been used).
